**COURSE DESCRIPTION:** This course is designed to expand your knowledge of musical traditions and styles, and enhance your ability to critically listen to music. Much of this course will be historically based and will focus on the political, cultural, and social aspects that shaped the musical style of each period. It is important that each student read the text and listens to music outside of class so that the full potential of this course can be fulfilled.

**GOALS AND OBJECTIVES:** The goal of this course is for you to acquire an understanding and knowledge of the development of music from the Middle Ages to present, and to understand how civilization and society effected all aspects of music throughout these centuries. You will also learn to understand music fundamentals such as melody and harmony.

1. Students will demonstrate the ability to recognize the basic elements of music and common musical instruments, both visually and aurally.

2. Students will demonstrate their understanding of significant historical facts and characteristics of the seven style periods of music history.

3. Students will demonstrate their ability to analyze and synthesize the sounds they hear with the knowledge of each style period, and determine the musical style period and medium of performance in listening examples.

4. Students will demonstrate their ability to write a review/critique of a concert/recital in which the student describes how the elements of music are used and states his/her attitude toward the performance.

# **METHODS OF EVALUATION**

1. You will be assigned weekly homework and complete a weekly quiz.

2. Other course requirements may require online asynchronous discussions, and internet searches, and listening.

3. There will be one proctored exam. Regardless of course average, MSVCC students failing to complete the proctored exam process will not be awarded a passing grade.

4. Each student may attend one live performance during the performance semester for extra credit. Each performance MUST be approved by me prior to attending. After attending the performance, each student is required to write a critical assessment (one page review) of the concert. There is a module for guidelines.

**ATTENDANCE POLICY:** Turning in assignments and taking tests **on time** equals being present in an online course. When a student turns in his/her assignments on time, he or she is noted as present. Those who do not turn in an assignment on time, or who do not turn it in at all, will be absent. Students should sign in at least twice weekly. In the fall and spring semester, students are allowed two absences. After two absences the student will be locked out of the class and must contact the instructor. There are certain circumstances in life that may disrupt even our best efforts and intentions.
