### **Course Objectives**

Students will develop a foundational understanding of the elements of art, the principles of design, a wide variety of media and artists working in those media, and a survey of Art History from Prehistory through the Italian Renaissance.

## **Student Objectives/Outcomes**

- 1. Have a basic knowledge of what art is and why it exists.
- 2. Be able to distinguish between the fine arts and minor arts.
- 3. Identify the meaning of art vocabulary used in each chapter of the text.
- 4. Identify the basic elements of art.
- 5. The student must recognize the basic principles of design.
- 6. Describe the different media and techniques with which the artist has to work.
- 7. Recognize specific works of art, the media used to produce them, and identify the artist of each work.
- 8. Analyze the social, economic, and political influences on art production.
- 9. Define major art movements and/or styles and identify artists associated with them.

## **Instructional Techniques**

## **Teaching Methods**

The course will include weekly chapter reading assignments, weekly chapter study guides, weekly chapter quizzes, essay writing asignments, Internet searches, and videos.

#### **Methods of Evaluation**

Evaluation is determined from a combination of Weekly Chapter Quizzes, Essay Writing Assignments, the Midterm Exam, and the Final Exam.

The following criteria will be utilized in determining your final grade:

- 1. 25% Chapter Quizzes
- 2. 25% Essay Questions

You will have Seventy-Two hours after the due dates to make-up assignments. Ten points will be deducted for late work.

- 3. 50% 2 Proctored Tests (25% Midterm Exam & 25% Final Exam)
- 4. Extra Credit Video Quizzes
