ART 1113/ART APPRECIATION

COURSE DESCRIPTION: This course is designed to provide an understanding and appreciation of the visual arts. Upon successful completion of this course, the student will have gained an understanding of the plastic arts (drawing, architecture, sculpture, painting, graphics, minor arts and industrial arts) on a conceptual basis. Evaluation is based on the results of chapter tests, practice tests, and a report. Three semester hours of credit may be earned upon successful completion of this course.

INSTRUCTIONAL TECHNIQUES: TEXTBOOK: Gardner's Art Through the Ages, 4th edition, Fred Kleiner.

Students will need to have access to the internet.

Students will be required to attend an art exhibition and write a report describing their experience

LEARNING OUTCOMES: The student will be familiar with and will demonstrate his/her knowledge of art and artists as they relate to the major time periods of civilization as well as the fundamentals of visual art. To demonstrate this knowledge the student needs to score 70% or better on all tests and complete all assignments in the required time.

EVALUATION METHODS: There will be chapter quizzes to be completed each week and one proctored exam.

ATTENDANCE: Students will be required to check into class and actively participate at least once a week. Accelerated classes require students to check into class and actively participate at least twice a week. All assignments and tests should be completed by the required date. Students will be dropped from the class for non attendance at the 60% class date.
